Executive Summary

The publication of this Final Report and Determination (Final Report) concludes the Northern Territory National Electricity Rules (NT NER) consultation process conducted by NTESMO on proposed changes to the NTESMO Communications Guideline.

The Draft Report was published on 29 November 2024 detailing the proposed changes. NTESMO received 2 submissions from participants.

NTESMO has developed section 9 of the Communications Guideline to include interim market procedures to apply in the NTEM.

NTESMO has additionally made the following changes to the Communications Guideline procedure document:

Due to the recent delays to the anticipated commencement date for the NT use of MSATS, NTESMO has removed the end date for the interim procedures linked to the compliance date in the NT Regulations. This provides NTESMO with greater flexibility in determining the applicable operating period for the interim procedures. The interim procedures will now be in operation up to the time NTESMO provides a market notice to all participants. That market notice will provide participants with 45 calendar day notice prior to the conclusion of the interim procedures and adoption of the use of MSATS in the NT.

1. Stakeholder Consultation Process

NTESMO is consulting on the proposed changes to the Communications Guideline in accordance with the Rules Consultation Procedures in clause 8.9 of the NT NER, as required by clause S7A.1.3 of the NT NER.

NTESMO's indicative timeline for this consultation is outlined below. Future dates may be adjusted depending on the number and complexity of issues raised in submissions.

2. Background

2.1 NT NER requirements

NTESMO is responsible for the establishment and maintenance of a Communications Guideline specified in S7A.1.3 of the NT NER.

The Communications Guideline authorised by NTESMO under Chapter 7A must be established and amended by NTESMO in accordance with the Rules consultation procedures.

2.2 Context for this consultation

NTESMO has developed the Changes to improve the functionality and efficiency of information exchange transactions between the NTEM participants. The Changes were developed by NTESMO. In summary, the Changes are to:

 Include interim procedures into the Communications Guideline to address a market discrepancy which has caused participants to not be transacting in accordance with the Communications Guideline

The Communications Guideline authorised by NTESMO under Chapter 7A must be established and amended by NTESMO in accordance with the Rules consultation procedures.

The proposed effective date for the documents is 24 January 2025.

2.3 First stage consultation

On 18 October 2024, NTESMO issued a Notice of First Stage Consultation and published an Issues Paper and initial draft amended procedure document. This information is available on NTESMO's website.

The Issues Paper included a summary of the proposed changes.

In response, NTESMO received 3 submissions.

NTESMO has published copies of all written submissions (excluding any confidential information) on NTESMO's website.

2.4 Second stage consultation

On 29 November 2024, NTESMO issued a Second Stage Consultation and published a draft determination procedure document. This information is available on NTESMO's website.
